- 4. <u>Term</u>. This Agreement shall be effective for a period of ninety (90) days from the Effective Date or such longer period as Seller and Selling Broker may agree in writing (the "Term"). If a Purchase Agreement is executed between Seller and Purchaser during the Term of this Agreement, then the Term of this Agreement shall be extended until such time as (a) the Purchase Agreement has been terminated by either Purchaser or Seller pursuant to the terms of the Purchase Agreement or (b) the closing of the sale and transfer of the Property by Seller to Purchase has occurred, whichever date first occurs.
- 5. <u>Consent or Waiver</u>. No consent or waiver, expressed or implied, by any party hereto of or to any breach or default by any other party hereunder shall be deemed or construed to be a consent or waiver of or to any other breach or default hereunder of the same or any other obligations of such parties.
- **6.** Entire Agreement. This Agreement contains the entire understanding of the parties and may not be changedor modified except by written instrument signed by both Seller and Selling Broker.
- 7. **No Partnership**. Nothing contained in this Agreement shall constitute or be construed to be, or create, a partnership or joint venture between Seller and Selling Broker, or their successors and assigns.
- 8. <u>Successors and Assigns</u>. This Agreement shall inure to the benefit of and be binding on the parties hereto and their respective heirs, successors, legal representatives and assigns.
- 9. <u>Governing Law</u>. This Agreement and the obligations of the parties hereunder shall be interpreted, construed and enforced in accordance with the laws of the Commonwealth of Kentucky.
